The *Adventures in Duckport* series will feature the original Suzy's Zoo character set, which includes the duck Suzy Ducken and her friends Jack Quacker, Penelope O'Quinn, Corky Turtle and others. The series will be targeted to children ages 4-8 and will follow the fun-filled adventures of these adorable characters as they interact, and show respect and love for, the elder members of their community. Suzy, Jack, Penelope, Corky and all their friends will do their best to help their elderly neighbors, even if they end up in a pickle doing so!

A sample of the *Adventures in Duckport* animated series will be presented for the first time at MIPCOM 2015.

In March 2015, Public Media Distribution, LLC released *Suzy's Zoo: A Day with Witzzy* (\$6.99) on DVD. This DVD is approximately 50 minutes and features 26 adorable two-minute stories that follow the duckling Witzzy and his stuffed animal friends.
